

## Our Terms and Conditions Agreement, Effective 09/29/2015

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS AGREEMENT CAREFULLY BEFORE ENROLLING & PARTICIPATING IN A COOKING CLASS AT THE COOKING SCHOOL AND/OR USING THIS SITE. You agree that class attendance & participation and access to & use of this Site are subject to the following terms and conditions and other applicable law. If you do not agree to these terms and conditions, please do not register for class nor use this Site.

### **Basic Definitions**

In this document: (1) "COOKING SCHOOL," means Sewickley Cooking Studio, LLC d/b/a Gaynor's School of Cooking; (2) "Site" means www.gaynorsschoolofcooking.com; (3) "our(s)," "we," and "us" means the COOKING SCHOOL and the Site; (4) "you('re)," "your," or "customer" mean a website visitor/user, account holder, class purchaser, class participant or any other user of our Services; (5) "Service(s)" means use of and anything provided on our Site, excluding third party links, and attendance, participation, product(s), and any instruction offered and/or provided by/at the COOKING SCHOOL. ### Refund Policy

We DO NOT offer refunds UNLESS a class is cancelled by us due to insufficient registration or other extenuating circumstances. ANY CHANGES must be made AT LEAST ONE WEEK prior to class, AND will incur a \$15 processing fee for an INDIVIDUAL class OR \$50 for a cooking class SERIES. IF you used a DISCOUNT COUPON your processing fee will be \$25 for an INDIVIDUAL class OR \$60 for a cooking class SERIES. \*BY DEFAULT, REFUNDS WILL BE CREDITED TO YOUR HOUSE ACCOUNT – REFUNDING CREDIT CARDS ARE BY REQUEST ONLY\* \*\*\*NO CANCELLATION/CHANGE WILL BE ACCEPTED IF MADE WITHIN ONE WEEK OF THE DATE OF THE CLASS\*\*\*
